### **About:**

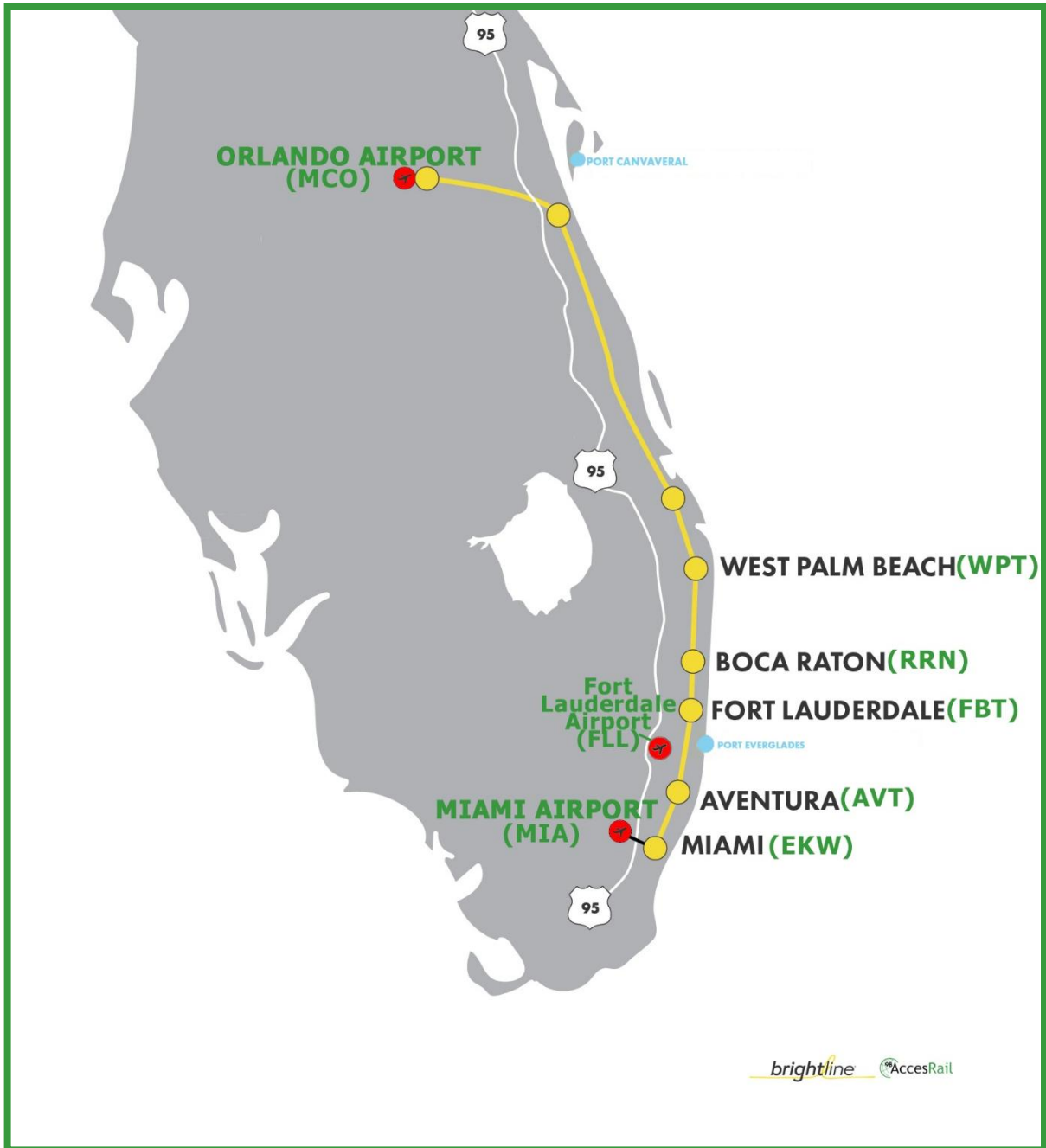

### **Services:**

Passengers can travel in Premium (J) or Smart (Y) class.

Passengers in Premium class can enjoy travel in large comfortable chairs, complimentary Wi-Fi, access to a power socket at their seat, complimentary snack and drink, and access to the Premium lounge.

Passengers in Smart class can enjoy travel in comfortable chairs, complimentary Wi-Fi, and access to a power socket at their seat.

### **Pets:**

Passengers may bring their cat or dog on board in a carrier. Pets must be added to the reservation at least 10 minutes prior to train departure. This can be done at the train station. Fees may apply.

### **Eligibility:**

Infants 2 years of age and under ride free without a ticket if no seat is required. The infant must be accompanied on all services in the same compartment by an adult.

Child fare is only available for children under the age of 13 in Smart Class on routes to and from Orlando. Child fare is not available in Premium class or on other routes.

Tickets are only valid for the OD pair indicated on the ticket.

No applicable discounts for airline staff.

No unaccompanied minors permitted.





Refunds are according to Airline Tariff Rules.

**Carrier Conditions apply.**

**Group Bookings:**

To book groups: Up to 9 passengers with unique names per PNR when booking with 9B AccesRail. Example: A group of 20 will be booked on three different PNRs (PNR 1: 9 pax, PNR 2: 9 pax, PNR 3: 2 pax).

### Check-in Process:

**Check-in is essential to ensure a smooth travel experience.**

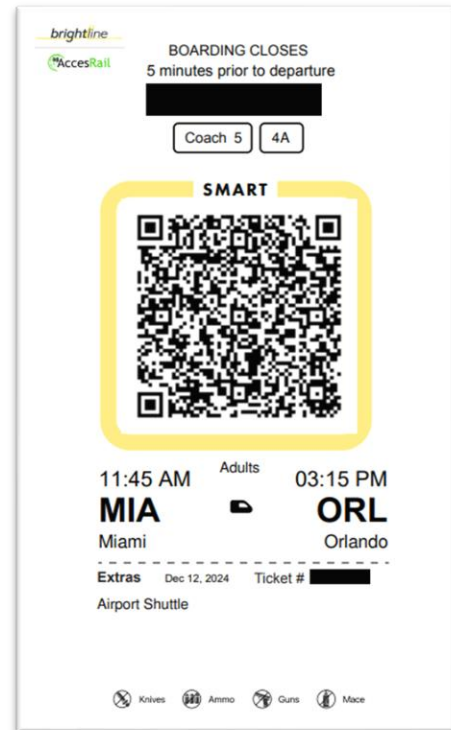



Figure 12: Brightline Train Ticket Example

Passengers must check-in to retrieve their actual travel documents (See Figure 12). Check-in can be done beginning 72-hours prior to departure. Check-in is done on <https://check-in.accesrail.com> (See Figure 13) using the passenger's name as it appears in the booking and either the booking reference or 13-digit ticket number.

Passengers who arrive at/depart from Miami Airport will receive their ticket which indicates that they can take the shuttle bus and a Second page of instructions on how to go between Miami Airport and Brightline Miami Train Station.

Seat reservations are included.

## How to Get to the Train:

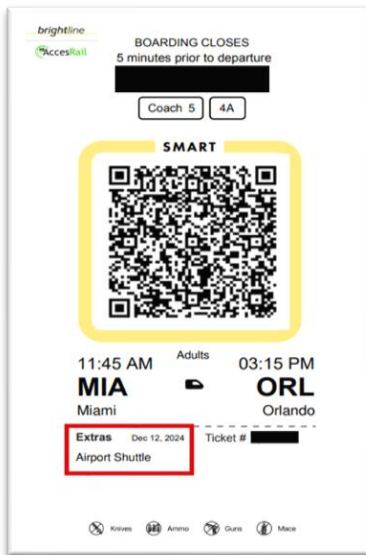


Figure 14: Train Ticket with Airport Shuttle

### Miami:

Tickets for passengers who arrive at or depart from Miami Airport will show “Airport Shuttle” at the bottom of the ticket (See Figure 14) and a Second page which contains instructions on how to go between Miami Airport and Brightline Miami Train Station. Passengers will use the Brightline shuttle bus (See Figure 17).

At Miami Train Station passengers will go from the ground level, exit through the east exit past Joe & The Juice to the pickup area to board the shuttle.

At Miami Airport passengers will be able to board the shuttle at the North Terminal, Concourse D, Door 6, Bus Zone 1; Central Terminal, Concourse E, Door 11, Bus Zone 2; and South Terminal, Concourse H, Door 22, Bus Zone 4.

### Orlando:

At Orlando Airport passengers will [make their way to Terminal C](#) to take the Brightline train. Passengers who arrive at Terminal A and B can take the terminal link to Terminal C. Once at Terminal C, passengers can follow the signs from the pedestrian bridge to the train station.

Passengers departing from Orlando Airport can follow the singage from the train station to the pedestrian bridge to Terminal C. From Terminal C passengers can take the terminal link if they are [departing from Terminal A and B](#).

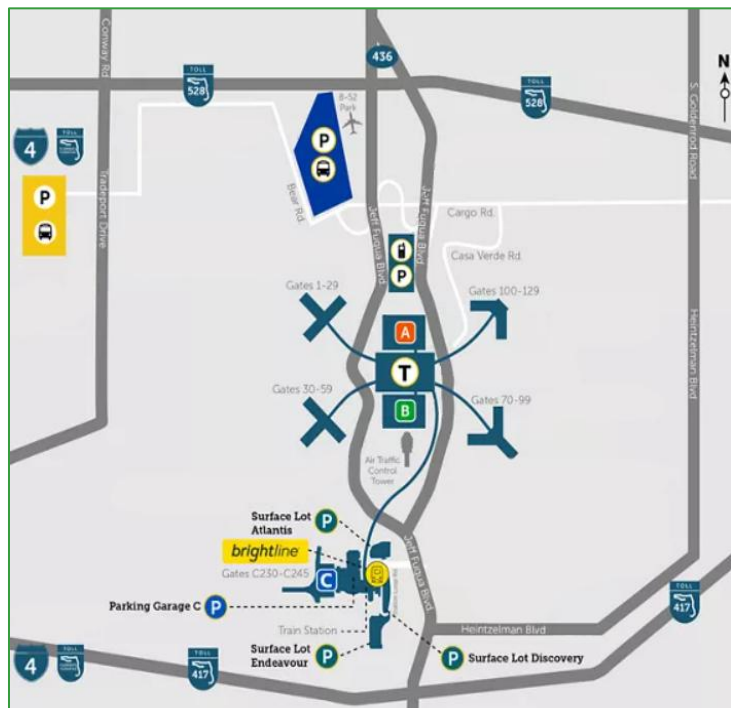


Figure 15: Orlando Airport Map, Brightline Train Station



### **Fort Lauderdale:**

Passengers can take the shuttle bus from :05 minutes to :20 minutes after the hour and between :50 minutes and :05 minutes after the hour. Please arrive at the stop for the beginning of the pickup window and allow +/-10 minutes for traffic.

#### **Stop 1: Terminal 1**

On the arrivals level, exit through Door 114. Turn right upon exit and walk straight ahead to Ground Transportation Zone B. The Brightline Shuttle stop is located at this sign, marked by the red letter "B", directly under the yellow pedestrian walkway from the parking garage, just before the pet relief area.

#### **Stop 2: Terminals 2 & 3**

On the arrivals level, walk to the Ground Transportation area located between Terminals 2 and 3. If coming from Terminal 2, turn right. If coming from Terminal 3, turn left. Walk to Ground Transportation Zone F, marked by the red letter "F". The Brightline Shuttle stop is located at this sign.

#### **Stop 3: Terminal 4**

On the arrivals level, exit through Door 414. Turn right upon exit and walk straight ahead to Ground Transportation Zone B. The Brightline Shuttle stop is located at this sign, marked by the red letter "B", directly under the white awning, at the end of the walkway.

### Getting to Miami Train Station from International Airport (MIA)

Your train ride starts at Miami Station.

Your train ticket includes a shuttle service from the airport to the train station.

Pickup window at the airport is from :45 minutes after the hour to :05 minutes after the hour.

Please arrive at the stop for the beginning of the pickup window and allow +/- 10 minutes for traffic.

#### Shuttles boarding points:

- North Terminal, Concourse D, Door 6, Bus Zone 1
- Central Terminal, Concourse E, Door 11, Bus Zone 2
- South Terminal, Concourse H, Door 22, Bus Zone 4

#### Hours of operation:

Mon - Sun 7:20am – 7:55pm. First shuttle departs the airport at 7:45am, last shuttle departs the airport at 7:55pm.

### Baggage Policy

#### Carry-on Items

Up to two (2) carry-on items per passenger are allowed on board BL trains, subject to space availability. Each standard size carry-on item must not exceed 50 lbs. (22 kg) in weight and 24" x 16" x 10" (61 x 41 x 25 cm) or 50 linear inches (127 linear cm) in exterior dimensions. Items must fit comfortably within the overhead luggage area, under the seat or in the luggage tower available in each train coach. Items may not be stored in empty seats, aisles, vestibules or other areas where they present a safety hazard or cause annoyance to other passengers.

Additional small personal items needed for the duration of the trip may be carried on the train and will not count toward the carry-on allowance. Such items include but are not limited to:

- Required medical devices and containers
- Pillows, blankets and outer garments
- Small briefcases and purses

#### Checked Bag

- Brightline will waive fees up to (2) Checked bags in SMART Business Class and PREMIUM First-Class, 3+ bags are subject to baggage fee
- Documentation will need to be provided: AccesRail/Brightline Boarding Pass, Inbound/Outbound Flight Boarding Pass
- Limited space available for Checked Bags
- Must check-in 40 minutes prior to departure at Guest Services to Check Bags.
- For stations with no Guest Services desk, the customer has to bring all bags on the train (no checked bags).

### At Brightline Train Stations:

At Brightline train stations passengers will go through security before boarding the train. Passengers will have their luggage scanned at the station and must pass through a metal detector.

Passengers are prohibited from bringing hazardous material with them on board: Firearms, ammunition, incendiary devices, sharp objects, containers with propellants, gasoline-powered hand tools, flares/flare guns, corrosive or dangerous chemicals, mace or pepper spray, bows, crossbows or arrows, martial-arts and self-defense items.

### Prohibited Items

Weapons of any type (including but not limited to those listed below) are not permitted on our property, including in any station, or on board the train, in either carry-on or checked baggage.

Examples of Prohibited Item:

- **Firearms** to include but not limited to handgun, shotgun, rifle, **BB** gun and starter pistols.
- **Incendiary devices**, including but not limited to: flammable gases; liquids; fuels; fireworks; gunpowder or other explosive devices
- **Canisters, tanks or other devices** containing propellants
- **Oxygen equipment** for medical reasons is allowed on board (please see safety and security personnel for assistance)
- **Gasoline-powered hand tools**
- **Flares or flare guns**

- **Batteries with acid that can spill or leak.** Such batteries that would power mobility assistance vehicles are allowed.
- **Corrosive or dangerous chemicals or materials**, including but not limited to: liquid bleach; tear gas; electronic control devices (stun guns and Taser guns); radioactive or harmful biological material.
- **Mace or Pepper Sprays**
- **Sharp objects**, including but not limited to: scissors; knives; straight razors; ice picks; axes; and swords.
- **Bow, crossbow and/or arrows**
- **Martial-arts and self-defence items**, including but not limited to batons, billy clubs, nightsticks, and nunchakus

Passengers failing to meet the above-mentioned requirements will be denied transportation.

### **Luggage:**

Brightline luggage rules apply. Passengers must be able to carry their luggage to their respective train and vice-versa. Passengers are responsible for their own luggage during the train journey.

### **Carry-on Items:**

Up to two (2) carry-on items per passenger are allowed on board BL trains, subject to space availability. Each standard size carry-on item must not exceed 50 lbs. (22 kg) in weight and 28" x 22" x 14" (71 x 56 x 35 cm) or 64 linear inches (162 linear cm) in exterior dimensions. Items must fit comfortably within the overhead luggage area, under the seat or in the luggage tower available in each train coach. Items may not be stored in empty seats, aisles, vestibules or other areas where they present a safety hazard or cause annoyance to other passengers.

Additional small personal items needed for the duration of the trip may be carried on the train and will not count toward the carry-on allowance. Such items include but are not limited to:

1. Required medical devices and containers
2. Pillows, blankets and outer garments
3. Small briefcases and purses
4. Umbrellas
5. Non-alcoholic liquids and food

### **Checked Bag:**

1. Brightline will waive fees up to (2) Checked bags in SMART Business Class and PREMIUM First-Class, 3+ bags are subject to baggage fee.

2. Documentation will need to be provided: AccesRail/Brightline Boarding Pass, Inbound/Outbound Flight Boarding Pass.
3. Limited space available for Checked Bags.
4. Must check-in Must check-in 40 minutes prior to departure at Guest Services to Check Bags.
5. For stations with no Guest Services desk, the customer has to bring all bags on the train (no checked bags).

### **Prohibited Items:**

Weapons of any type (including but not limited to those listed below) are not permitted on any Brightline property, including in any station, or on board the train, in either carry-on or checked baggage.

#### *Examples of Prohibited Items*

- Firearms to include but not limited to handgun, shotgun, rifle, BB gun and starter pistols.
- Incendiary devices, including but not limited to: flammable gases; liquids; fuels; fireworks; gunpowder or other explosive devices
- Canisters, tanks or other devices containing propellants
- Oxygen equipment for medical reasons is allowed on board (please see safety and security personnel for assistance)
- Gasoline-powered hand tools
- Flares or flare guns
- Batteries with acid that can spill or leak. Such batteries that would power mobility assistance vehicles are allowed.
- Corrosive or dangerous chemicals or materials, including but not limited to: liquid bleach; tear gas; electronic control devices (stun guns and Taser guns); radioactive or harmful biological material.
- Mace or Pepper Sprays
- Sharp objects, including but not limited to: scissors; knives; straight razors; ice picks; axes; and swords.
- Bow, crossbow and/or arrows





- Martial-arts and self-defense items, including but not limited to batons, Billy clubs, nightsticks, and nunchucks.

Passengers failing to meet the above-mentioned requirements will be denied transportation.

### **Food and Beverage:**

Passengers have access to food and drinks at the train stations, as well as on the train. At Orlando, Fort Lauderdale, West Palm Beach, and Miami passengers can purchase drinks at the Mary Mary Bar. Passengers can purchase food at MRKT at Aventura and Boca Raton stations, and MRKT Place at Orlando, West Palm Beach, Fort Lauderdale, and Miami.

Passengers with Premium tickets have access to the Premium lounge where passengers can enjoy complimentary snacks and drinks.

### **On-board Meals:**

Passengers in Premium class can enjoy complimentary snacks and beverages while on board, as well as complimentary breakfast for travel between Orlando and Miami.

Passengers in Smart class can enjoy snacks and beverages purchased from the onboard menu.

### **Mobility Assistance:**

For wheelchair space reservation please use SSRs: WCBBD, WCBW, WCHC, WCLB. If confirmed, a wheelchair space will be reserved. Assistance getting on and off is not guaranteed.

### **Delays:**

In case of train delays, passengers must contact the issuing airline carrier for assistance.

In case of flight delays, passengers will be accommodated by visiting the Brightline Trains USA Service Desk. However, the same class of service is not guaranteed in such cases.





### **SSR Message:**

Please note that the SSR message will contain check-in information. For wheelchair space reservation please use SSRs: WCBD, WCBW, WCHC, WCLB.

### **FAQ:**

1. Is Brightline a BUS or TRN?  
Brightline is a train (TRN) service. Note, a shuttle service between MIA and EKW.
2. Do I have to check-in?  
Yes, passengers must check-in in order to receive their actual travel document which they will use to board the train. Passengers can [check-in on AccesRail](#) for each segment of their journey.
3. Can I upgrade my ticket?  
Unfortunately, tickets are unable to be upgraded at the station or while on the train.
4. How do I get to Miami Brightline Station from Miami Airport?  
A shuttle service is available for passengers booked to/from Miami Airport (MIA). Tickets will indicate if shuttle is included under “Extras”.
5. Can I get off the train at a station before the one indicated on my ticket?  
Tickets are only valid for the points indicated on the ticket; passengers must travel from origin to destination as booked.
6. How early should I arrive at the train station?  
Passengers should arrive at the train station 30 minutes prior to train departure.
